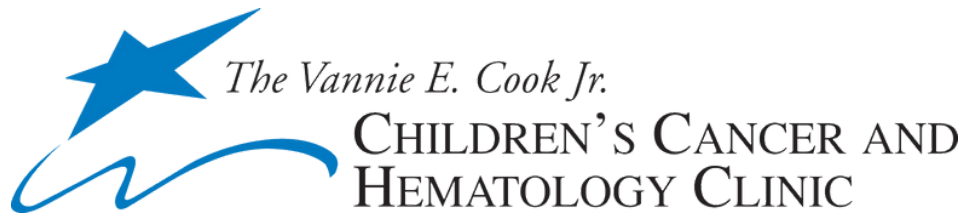

OFFICIAL RULES 2024

- One person on the team must attend the Captain's Meeting.
- All entrants must have registration form on file by 8:00PM, Friday, June 7, 2024 at the Captain's Meeting. Anglers will receive their boat number and an overview of the rules. No registration on day of tournament.
- All live and artificial bait is allowed. All fish must be taken by rod and reel. No cast nets, bow fishing, gigging, etc.
- Entrants must have a valid 2024 Texas Fishing License and Saltwater Stamp. All Texas Parks & Wildlife laws apply.
- Each person in the boat MUST BE entered in the tournament, (Max 4 people per boat including the Captain).
- One pole per angler. You can have more than one rod and reel on the boat, but you cannot fish with more than one at a time.
- No fish pooling is permitted between teams. Only fish caught by team members on the weigh in date are eligible for official weigh in. Pooling of fish will result in disqualification.
- Wade fishing is permitted only if area was accessed by boat. All team members must remain within eyesight of each other and boat at all times.
- All fishing areas must be available to the general public.
- Fishing hours are from 6:00am – 3:00PM Saturday, June 8, 2024. Boats can leave the docks at 5:30AM. No check in on day of tournament required to start fishing. All entered fish must be caught during tournament fishing hours.
- Weigh in will be at Louie's Backyard from 1:00PM – 3:00PM. You must be in line ready to weigh in by 3:00PM. NO EXCEPTIONS.
- Fish must be fresh and in edible condition. No altered or mutilated fish will be accepted.
- Our scales and ruler will be the only official measuring device.
- Winning fish will be determined by weight. Ties will be broken by length. Lengths will be measured using the Check it Stik Slant board with the Perfect Trout Pincher & Perfect Red Pincher measuring format. Perfect Pinchers will be run to 1" under slot max for Trout exceeding 19" and Redfish exceeding 27". Trout under 19" and Redfish under 27" will be pinched by hand. Flounder tails will be pinched by hand.
- Qualifying Fish are Redfish, Speckled Trout, and Flounder.
- Bag Limits are one fish per species per team. Maximum of three fish per team.
- Size Limits are based on current regulations set forth by Texas Parks & Wildlife. Redfish (20-28"), Speckled Trout (15-20"), Flounder (15"-No Max). No oversized fish are allowed in any category. Oversized fish will disqualify entrant's fish.
- No substitutions of fish other than the one brought in. If fish is disqualified for any reason, it cannot be replaced with another fish at any time.
- Teams are responsible for proper identification of their catch for each category prior to arriving at the dock. Weighmaster will not weigh multiple fish of the same species to determine which fish is heavier. The fish you pick is the fish you enter.
- All weighed fish will be marked.
- Tournament Director's watch will be used for Official Time. There will be an announcement made at the Captain's Meeting at 7:30pm, Friday June 7, 2024.
- All anglers, including minors agree to take a polygraph test if required by a Friends for Hope member or the Friends for Hope weigh master. Failure to take or pass a polygraph test will result in disqualification from this tournament and all future tournaments. If the angler is a minor, a parent or legal guardian shall agree for the minor to submit to such polygraph testing.
- Any grievance must be brought to the attention of the tournament director prior to 3:00PM on Saturday, June 8, 2024. Grievances must be in writing. Person filing the grievance must pay \$200 (non-refundable) when submitting. Fish weight cannot be protested. If length call is protested, fish must remain with Weighmaster immediately following the initial measurement of the fish.
- All decisions of The Weight Master and Friends for Hope board are final.
